



## 2023 MEMBER CONTRACT

**The following five criteria must be met to be eligible to become a FLWA member:**

1. Members must be a Federal or State licensed Farm Winery or Winery.
2. Member's winery must be in the Finger Lakes AVA or contiguous to the AVA.
3. Members must be currently selling a minimum of 75% Finger Lakes AVA wines that are also produced and bottled by a winery in the Finger Lakes AVA.
4. In order to be a member, a licensee must produce at least 2500 gallons of wine annually and own 60% of either;
  - a) A wine production facility in the Finger Lakes AVA  
OR
  - b) 10 acres of producing vineyards in the Finger Lakes AVA that are being used to produce their wines  
OR
  - c) A tasting room in the Finger Lakes AVA
